# DeKalb County Promise Enrollment is OPEN!

Do you have a child, age 4 to Grade 3? An opportunity to enroll your child in a DeKalb County Promise 529 Career Savings Account has arrived! IF you're ready now, you may enroll online at [www.dekalbcountypromise.org](http://www.dekalbcountypromise.org). If not, please watch for an enrollment event happening at your child's school this Spring.

Just for signing up, DeKalb County Promise will automatically deposit \$25 into your child's account for learning beyond high school. This money may be used for a variety of post-high school education or training programs.



Though it's encouraged, families are not required to make a deposit when enrolling. By matching the initial \$25 incentive with another \$25 from champions in your child's life, families will automatically receive an additional \$75 gift from the community. This ensures your child has a career savings account worth at least \$125 for post-high school education or training programs. Starting to save early gives the fund time to grow. ## Lilly Endowment Inc. offers Seventh Phase of its Giving Indiana Funds for Tomorrow (GIFT) Initiative

Are you willing to touch the lives of people you'll never even meet, now and forever across DeKalb County? Thanks to Lilly Endowment Inc.'s recent grant opportunity, we can triple your gift and triple the impact of your donations to our unrestricted/grantmaking fund.

The Community Foundation of DeKalb County received a \$500,000 matching grant in December to build its financial assets and support charitable activities. According to Board President Matt Bechdol, "the majority of these matching funds are directed to our unrestricted funds used for community grantmaking. Because these are the most difficult dollars for us to raise, this will have a major impact on our ability to address the changing needs over the years and generations." Donations to the unrestricted community grantmaking fund are eligible for the \$2:\$1 match through December 2020, or until this goal has been met.

GIFT VII also offers us a tremendous opportunity for the county to identify the most promising opportunities and pressing challenges that we have the capacity to address. Expect to see us engaging the community, developing new relationships, and building our internal capacity to focus on community leadership throughout 2019.

## Board of Directors Spotlight: Kathie Swaim

## Campaign Creates New Endowment Fund

During our 2018 Spread Holiday Cheer Campaign, charitable organizations without an endowment fund with the Community Foundation were encouraged to create a fund, which allowed them to participate in the campaign and receive match money. One of the funds created during the Campaign was the RISE, Inc. Endowment Fund.

RISE is a human services agency in Northeast Indiana with a mission to compassionately partner with families and individuals with economic, physical, and developmental challenges. A majority of RISE's clients reside in DeKalb and Steuben counties. Personalized services and advocacy for independence, quality of life and hope are provided.
