

MAKING A DIFFERENCE THROUGH UNRESTRICTED FUNDS

Two of the services provided by a community foundation are 1) assisting donors in funding their causes in perpetuity and 2) funding nonprofit and charitable organizations that are addressing community issues.

While some donors have particular thoughts on their causes, others have more general thoughts. In those cases, donating to, or opening an unrestricted fund can be a powerful philanthropic strategy that can impact your community. An unrestricted fund is a pool of money that does not come with any donor-imposed restrictions, which gives the organizations the flexibility to use those funds for the greatest needs. However, that does not mean there is no oversight of those funds.

The Community Grantmaking Endowment Fund, which is the largest unrestricted fund at CFDC is used for the Foundation's quarterly grantmaking. The Foundation has staff and volunteers who diligently review and discuss every grant application to ensure the grantee's fiscal responsibility, strong governance, adequate staffing, collaboration efforts, and long-term sustainability plans for the program/project and organization. The Community Grantmaking Endowment Fund also supports grants for operations, and capacity building because strong programs/projects are only run by strong organizations. Funds from the Community Grantmaking Endowment Fund stay in the county.

Nonprofits are often the only entities addressing vital issues like food insecurity, homelessness, mental health, and abuse (children, animals, elderly, women), to name a few, in a community. Our world needs our nonprofits, and our nonprofits need us. A donation to the Community Grantmaking Endowment Fund is a great way to support our nonprofits and our community!
